VICTORIES FOR FREEDOM

THE ACLJ SCORED REMARKABLE VICTORIES THIS PAST YEAR

The “Genocide” Designation

The ACLJ has advocated strongly and consistently for the Islamic State’s (ISIS) atrocities against Christians to be officially designated as “genocide,” in order to set in motion the United Nations (U.N.) Congress on Genocide and activate legal protections and other actions.

Our advocacy has contributed to significant victories in this fight; the United States Congress, Secretary of State John Kerry, and even President Barack Obama have all officially declared the “genocide” label.

We’ve also urged action in Europe, by calling on the European Parliament to recognize the genocide.

The ACLJ has developed a powerful seven-point action plan designed to stop ISIS genocide against Christians and other religious minorities. We’re advancing this plan on a daily basis through the largest legal advocacy campaign in our history.

Government officials have now admitted their Middle East policy failure, and many Christians’ lives are tragically at risk.

So we continue to fight. And we are making progress at the U.N., through the Secretary of State, the European Parliament, and the United States Congress. But, our work is far from over.

Supreme Court Victories

- *Texas v. United States* — President Obama’s Executive actions rewriting our immigration laws were unconstitutional, a blatant

example of his pattern of violating the U.S. Constitution. ACLJ Chief Counsel Jay Alan Sekulow testified before Congress that “impatient Presidents don’t get to change the law,” and the ACLJ filed an amicus brief in this case at the Supreme Court of the United States, as well as at the Fifth Circuit Court, on behalf of 113 Members of Congress. In an important victory, the High Court kept in place a federal injunction blocking the President’s unlawful actions.

- *Reed v. Town of Gilbert* — In a big victory for First Amendment liberties, the Supreme Court handed down a crucial decision on free speech rights at Good News Community Church of Gilbert, Arizona, allowing temporary signs promoting their worship services to stay. We argued in an amicus brief that the town’s sign code violated the First Amendment by making different rules for religious and non-religious signs. The Supreme Court Justices unanimously agreed with our brief.
- *Zubik v. Burwell* — The Supreme Court issued a unanimous *per curiam* opinion ordering lower courts to help the Little Sisters of the Poor and other religious organizations work out a compromise with the Obama Administration on the ObamaCare abortion-pill insurance-coverage mandate. This is a significant victory for religious freedom and for life. The ACLJ filed an amicus brief in this case at the Supreme Court.





Freedom for Saeed

After enduring 1,449 days locked up in Iran's most notorious torture prison, American Pastor Saeed Abedini was finally freed. Even the *New York Times* recognized that the ACLJ played a pivotal role: "The American Center for Law and Justice, an organization focused on the rights of Christians, gathered more than a million signatures on a petition protesting the imprisonment of Saeed Abedini, an Iranian-American pastor and convert from Islam who was one of four Americans freed.... For [other small] organizations, a million signatures for any cause would constitute a supernatural happening."

Freedom from IRS Abuse

In our fight against the Internal Revenue Service, the ACLJ secured a major victory in federal appeals court, which agreed with our position that the agency's targeting of conservatives has not ended and that our clients — numerous conservative, Tea Party, and pro-life groups — deserve to have their day in court.

In its opinion, the U.S. Court of Appeals for the D.C. Circuit agreed

that the First Amendment rights of the 38 non-profit organizations from 22 states we represent were violated. This result means that our case against the Obama Administration's IRS for the deliberate and illegal targeting of groups for their political beliefs can move forward.

SFC Martland Cleared

The ACLJ took action in support of Sgt. First Class Charles Martland, who was wrongly targeted for saving a child from horrific abuse in the Afghan war zone. The ACLJ mounted a massive advocacy campaign, sending critical legal letters to President Obama, the Army Chief of Staff,



Secretary of the Army, Secretary of Defense, and more. After six months of advocacy and 135,000 signatures on our petition, SFC Martland has now been officially exonerated.

Freedom of Conscience

Dr. Doris Fernandes was fired for her religious beliefs. For most of her 35-year career in medicine, her employer honored her religious objection against dispensing contraceptives, abortifacients, or referrals for such services to her patients. But as a result of ObamaCare, the City of Philadelphia's Department of Public Health mandated all of its doctors to participate in prescribing abortion-inducing drugs. When Dr. Fernandes requested a religious accommodation, she was fired.

We filed a lawsuit on behalf of Dr. Fernandes, and achieved a significant victory. The City of Philadelphia agreed to adopt a new policy respecting the conscience and religious rights of medical providers.

These are only a few of the many victories achieved by the ACLJ this year in our ongoing pursuit of FREEDOM with the strong support of committed members like you. Thank you!

FREEDOM FROM GENOCIDE

Even though we have scored initial victories in the fight against genocide, the ACLJ continues to work on this critically important issue. Time is of the essence because the atrocities continue. Executions, beheadings — even entire Christian communities exterminated by jihadists.

ISIS offers painful options to Christians caught in the crosshairs: convert to Islam or pay a large ongoing fine so devastating that life cannot go on. Your only other alternative: run for your life.

The ACLJ has developed a strong seven-point plan to stop the genocide:

1. OFFICIAL INTERNATIONAL COOPERATION
2. ACTION FROM THE U.N. OFFICE OF THE SPECIAL ADVISER ON THE PREVENTION OF GENOCIDE
3. PROSECUTION OF THE PERPETRATORS
4. A MULTI-STATE COALITION
5. A UNITED AMERICA TO LEAD THE WORLD
6. SAFE ZONES IN THE REGION
7. STRONG MILITARY RESPONSE

FREEDOM FROM BIG ABORTION

The ACLJ is pursuing three major pro-life cases:

Planned Parenthood v. CMP and *National Abortion Federation v. CMP* — In these twin cases, the Center for Medical Progress (CMP) is being sued by Big Abortion to prevent the release of additional videos depicting what a key congressional probe recently confirmed: Planned Parenthood broke the law and sold the body parts of aborted babies for profit. These cases have the potential to damage Big Abortion significantly.

Livingwell Medical Clinic v. Harris — A new law in California forces pro-life crisis pregnancy centers (many of them faith-based) to provide every client with a contact

FREEDOM FOR ISRAEL

Eleven Presidents in a row have stood firm in support of our ally Israel. From Harry Truman to George W. Bush, Israel could count on America's strong support. But now Barack Obama has the dubious distinction of being the first U.S. President ever to turn his back on Israel. Not only is he threatening to withhold a crucial veto on a deadly resolution at the United Nations — he is threatening to offer it as an American proposal! He would divide Jerusalem and give Christian holy sites over to radical Islamic jihadists — including Jesus' tomb, the Last Supper room, and the Mount of Olives. He would force Israel to accept pre-1967 borders, which are indefensibly narrow, inviting attack by enemies.

This betrayal could not come at a worse time for the Israeli people. Palestinian terrorists have launched more than 300



phone number for an entity offering a state-financed abortion.

The state can't tell a preacher what to preach. Or a newspaper what to print. Or a private school what to teach. But the State of California believes it can tell a pro-life crisis pregnancy center what to tell women who turn to them for help. If a pregnancy center refuses to display such a sign in their lobby — effectively acting as "salesmen" for the abortion industry, they can be fined thousands of dollars.

attacks on Israeli citizens, stabbing women and children, and murdering 30 civilians.

The ACLJ is fighting back, mobilizing our office in Jerusalem and preparing critical legal letters, documents, and filings at the U.N., in Congress, and with the State Department.

FREEDOM FROM LAWLESSNESS AND DECEIT (AMERICAN CENTER FOR LAW & JUSTICE V. UNITED STATES DEPARTMENT OF STATE)

In order to gain approval for President Obama's flawed Iranian nuclear deal, which puts Israel and the U.S. at terrible risk, the State Department admitted in a press briefing that *they lied to the American people about illegally negotiating with Iran*, the world's leading state sponsor of terrorism, even as Iran imprisoned and tortured U.S. citizens.

Then, to cover up the lies, the State Department intentionally deleted the portion of the video of the briefing including that admission.

The ACLJ has filed a federal lawsuit in the U.S. District Court in the District

of Columbia. *American Center for Law & Justice v. United States Department of State* seeks to expose the truth: Who ordered the deletion? What chain of command did it go through? Why was it deleted? And why did the State Department intentionally try to cover up its actions?

The Obama Administration must do more than simply pay lip service to the notion of government transparency and accountability. Until the American people know the full truth, the ACLJ will not back down.

In addition to American Center for Law & Justice v. United States Department of State, the ACLJ is preparing to file up to five or more additional lawsuits to expose the truth of the Obama Administration's lies, cover-ups, and blatant disregard for the rule of law.

The cases and issues we're engaged in right now are critically important to the future of your constitutional freedoms, to our ally Israel, to religious liberties around the world, and to the lives of the unborn. Please keep standing with the ACLJ as we fight for your values.



"BDS" — the anti-Israel movement of Boycott, Divestment, and Sanctions — is a global movement with the goal of stripping the Jewish State of its legitimacy and destroying its economy. BDS must be stopped, and the ACLJ is taking the lead in this battle. We are pursuing dozens of anti-Israel discrimination cases in the U.S., and representing clients who have been victimized by BDS:

- At Loyola University in Chicago, a young Jewish leader was harassed at a student event and falsely accused of violating the Student Code of Conduct. We took the case, and the student was quickly cleared of all charges.
- At the University of Texas, pro-Palestine students interrupted a public event, then orchestrated a media campaign to terminate the Israeli professor who hosted it. The ACLJ represented him, and he was cleared of any violations.
- And more.

We are also launching a massive multi-national legal advocacy effort that will make a huge impact across the U.S., at the United Nations, and among world leaders. To set it all in motion, we co-sponsored the largest-ever global conference focused on fighting back against efforts to delegitimize Israel and destroy its economy.

ACLJ Chief Counsel Jay Alan Sekulow delivered a major address at the conference. The rise of anti-Israel sentiment, he pointed out, is apparent in the U.S. and worldwide. A byproduct of that hatred is the BDS movement, whose unambiguous goal is the elimination of the State of Israel.

Jay outlined for the U.N. the ACLJ's multi-pronged legal and media advocacy strategy to combat the BDS movement:

1. Expose the true nature of BDS for what it is.
2. Identify and quash BDS manifestations,

including subtle ones that violate existing law and policy.

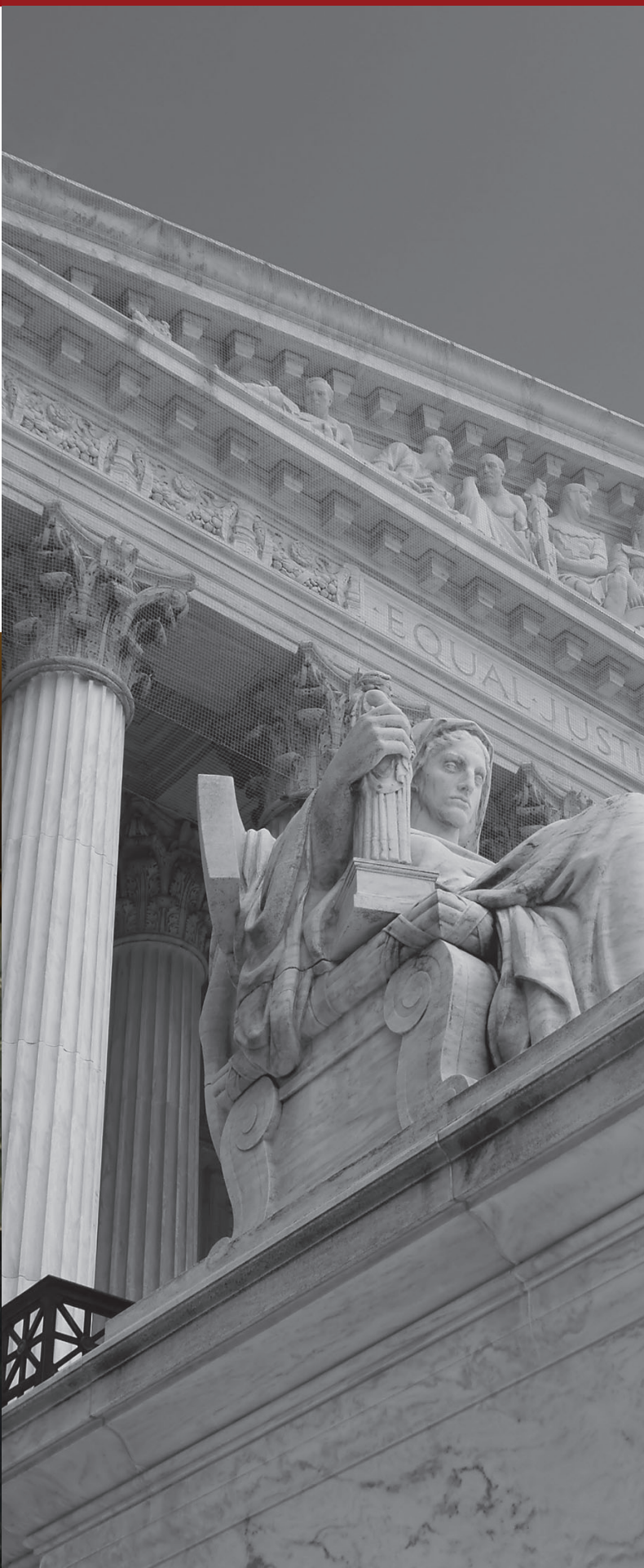
3. Enshrine in the law additional protections for Jewish citizens and Israeli interests.
4. Change the international conversation about Israel stemming from false BDS narrative.

BDS targets people of all faiths — anyone who supports Israel — but the ACLJ is fighting back effectively. Our strategy is already working. We have won victories against BDS at the Loyola University in Chicago, University of Texas, University of California, University of Michigan, UCLA, and City University of New York (CUNY), in addition to the American Studies Association.

MOBILIZATION
375,000 ACLJ members signed our petition for his freedom and our massive "Tweet for Youcef" campaign reached more than one million people.

ADVOCACY
The ACLJ brought major media coverage through *Jay Sekulow Live!*, ACLJ.org, and leading articles in the *Washington Post*.

LEGAL ACTION
We filed legal memos with the State Department, Members of Congress, International Embassies, and the U.N., bringing intense international pressure to Iran.

VICTORY
Pastor Youcef was released from prison after the ACLJ's efforts and intense public outcry, made possible by your support.

Pastor Saeed Abedini

MOBILIZATION
1.1+ million ACLJ members signed our petition for his freedom.

ADVOCACY
The ACLJ and our affiliates worked tirelessly, urging lawmakers and the President to pressure Iran to release Pastor Saeed.

LEGAL ACTION
We sent legal memoranda, testified before Congress, and represented the family of Pastor Saeed.

VICTORY
Pastor Saeed was released from an Iranian prison in January 2016, after more than three years in prison for his faith.

Army Sergeant First Class Charles Martland

MOBILIZATION
SFC Martland, a Green Beret war hero, faced expulsion from the military for defending a child from sexual abuse; 342,000 members signed the ACLJ's petition to have him reinstated.

ADVOCACY
We used heavy media presence to advocate and apply pressure to the military — working with strategic Members of Congress and growing a nationwide groundswell of support.

LEGAL ACTION
Apart from being on the front lines of the fight for SFC Martland — sending critical legal letters to the House and Senate Armed Services Committees, veterans organizations, the Army, and President Obama — we also submitted critical legal documents and testimony at the U.N. to stop the practice of abuse in Afghanistan.

VICTORY
SFC Martland was exonerated and remains in the U.S. military.

ADVOCACY EXPANSION

In order to increase our effectiveness in the ongoing battles for life and liberty, we are dramatically expanding our media presence across the U.S.

We have expanded our radio stations nationwide.

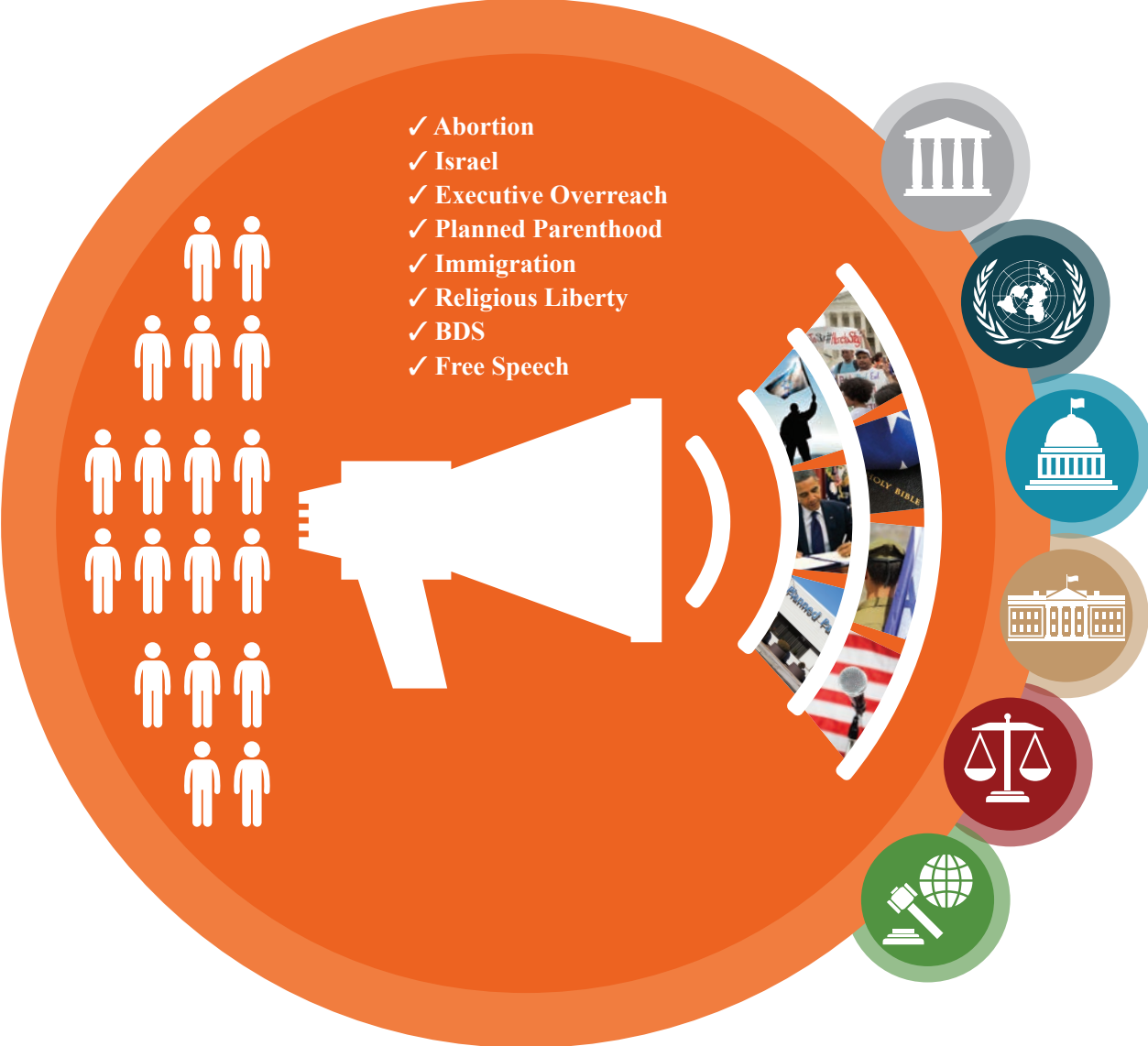
We are purchasing a building as a strategic new ACLJ Advocacy Center and expanding our advocacy team.

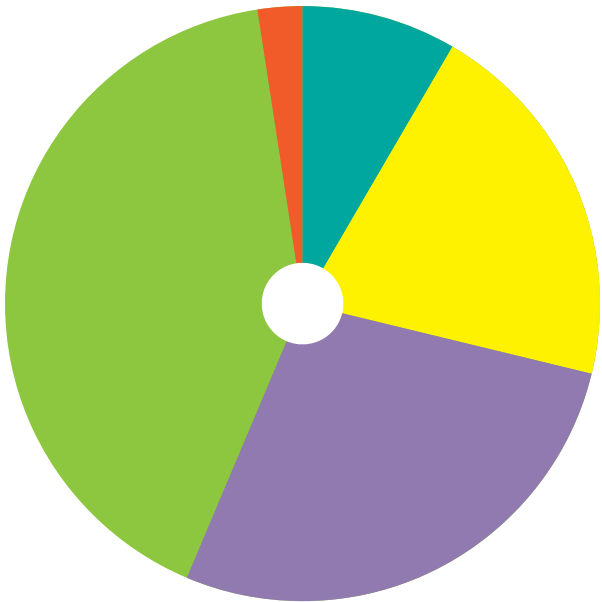

FIGHTING FOR FREEDOM THROUGH LEGISLATION

The ACLJ is actively involved in government affairs at both the state and federal levels. We've worked with Members of Congress in support of significant legislation this year:

- **Amendment #289** — The U.S. House of Representatives approved a measure calling for establishment of refugee safe zones.
- **H. Con. Res. 75** — The House unanimously passed a bipartisan resolution declaring ISIS atrocities against Christians to be “genocide.”

- **H.R. 3762** — The House passed a reconciliation bill that defunds Planned Parenthood and repeals large portions of ObamaCare supported by the abortion industry.
- **H.R. 1150** — The House implemented this resolution, representing key ACLJ proposals for battling international religious persecution.
- **H.R. 4038** — The House passed this bipartisan bill implementing ACLJ recommendations, requiring background investigations and certifications before aliens from Syria or Iraq are admitted to the U.S. as refugees.

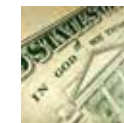
AT THE SUPREME COURT

The ACLJ litigates in state and federal courts across the nation, with a specific focus on the Supreme Court of the United States. In the past year, we filed amicus briefs in the following major, and other important, cases:

- ***Whole Woman's Health v. Hellerstedt*** — We argued for commonsense safety restrictions on abortion clinics.
- ***Texas v. United States*** — We stood against President Obama's illegal Executive action on immigration. *Victory! The Supreme Court ruled President Obama overstepped his authority when he unilaterally granted legal status to millions of illegal immigrants.*
- ***Zubik v. Burwell*** — We fought the ObamaCare abortion-pill mandate that forces religious organizations to violate their faith and pay for contraception and abortion pills. *Victory! The Supreme Court agreed — this was a huge victory for religious freedom!*
